At Lake Farm Park Academy, we aim to be an inclusive school and ensure equal opportunities throughout all aspects of our work and activities. We are committed to ensuring equality of education and opportunity for all pupils, staff, parents and carers, irrespective of race, gender, disability, belief, religion or socio-economic background. In order to further support pupils, raise standards and ensure inclusive teaching, we have set ourselves the following objectives:

- **Eliminate discrimination;**
- **Improving equality of opportunity for people with protected characteristics**

**Equality Objective One: Eliminating discrimination**

- To continue to monitor and analyse pupil achievement by race, gender and disability and act upon any trends or patterns in this data that require additional support for pupils.
- To support children and families with translation of verbal and written communication where appropriate
- To raise the aspirations of our most vulnerable pupils to ensure that our pupils have the knowledge and understanding to make meaningful decisions about their future.
- Encourage all pupils to be successful learners who enjoy learning, make progress and achieve their potential; to be confident individuals who are able to live safe, healthy and fulfilling lives; to be responsible citizens who make a positive contribution to society.
- To provide training to staff on how to effectively support our most vulnerable pupils and families.

**Equality Objective Three: Consulting and involving those affected by inequality in the decisions your school takes to promote equality and eliminate discrimination (this could include parents, pupils, staff members of the community).**

- To review levels of parental engagement in learning and school life across all activities to ensure equity and fairness in access and engagement
- To seek the views of our parents (questionnaires are completed by parents at parents evenings, parents surveys on Google Classroom, workshops evaluations, etc) and act upon feedback
- To promote and enhance community cohesion and a sense of shared belonging in the academy, and in the academy's neighbourhood e.g. school fairs, circus show, clearing rubbish in the Local Park, etc.
